Have you heard that you can enter a **Selfie** in the Curry County Fair? It's true. Here's the definition: single image of the photographer made by the photographer. Photo should "memorialize" a time or place for the photographer. An explanation MUST be included on the entry card. See pages 51-52 of the 4-H Exhibitors Handbook.

**Calling all writers!!** One new class for this year's Fair is Creative Writing. This includes poetry, a blog, or a short story. See pages 41-42 of the 4-H Exhibitors Handbook.

What's the difference between "Original Art" and "Non-Original Art?" Original Art is 100% from your own imagination. If you create your own version of another person's art, that is Non-Original Art. If you have any questions, see pages 44-46 of the 4-H Exhibitors Handbook.

There is a new class for this year's Fair. It is "Innovation and Creativity." You might say this is when you "supersize" a project. You add new learning from outside the project area which becomes included in your original project. Check out pages 48-49 of the 4-H Exhibitor Handbook.

Did you make a hay net to enter in Fair? This is in the "Fiber Arts" class. It is Filament Arts Macrame & Knotting. A 4-H Fiber Arts Exhibit Explanation card must be attached. See page 47 of the 4-H Exhibitor Handbook.

Did you make a felt pouch to enter in Fair? This is in the "Clothing & Sewing" class. It is Basic skills Level 1 Non-garment item sewn by hand. A 4-H Sewing/Clothing Exhibit Explanation Card must be with your exhibit. See page 54 of the 4-H Exhibitor Handbook. Are you a
