

## **Jaeger Fund Scholarship Application Guidelines & Directions**

Thank you for your interest in this 4-H event! Gilliam County 4-H is very fortunate to have additional monies available to 4-H Members who wish to attend local, regional and state events.

These scholarships are available to all 4-H Members in Gilliam County. The scholarship pays for the registration of the retreat. It will not cover any meals, snacks or transportation (unless provided by Gilliam County 4-H). The 4-H Member and Family is expected to contribute a minimum of 25% of the total registration cost and the scholarship will cover the remaining 75%. There are full scholarships available by contacting the 4-H Office.

If the 4-H Member decides not to attend the 4-H event, he or she forfeits the 25% that he or she paid at the time of registration unless there are extenuating circumstances.

For OSU Summer Conference, the 4-H Member and his or her family will provide a deposit of 25% of the cost of registration. If the 4-H Member attends, he or she will get that check returned. If the 4-H Member does not attend, the 25% will be forfeited.

A little about the Walt & Florence Jaeger Scholarship Fund:

Walt and Florence Jaeger met as young 4-H Members in 1926. They married 16 years later, and continued to remain very involved in 4-H, in leadership roles. When they passed away, their wheat ranch was sold and part of the proceeds were used to create an endowment with the Oregon 4-H Foundation. The fund was started in July 2007, and over \$100,000 has been used to support Gilliam County 4-H members to be able to attend OSU Summer Conference and other programs. In addition to the in-county enrichment programs, members have attended regional workshops, increasing their knowledge of their projects and their leadership skills. Leaders have been assisted in attending Oregon and Regional Leaders' Forums, enabling them to learn new skills to share with 4-H Members. This most generous support of the Walt and Florence Jaeger Endowment has provided numerous opportunities for the youth and volunteer leaders to participate at the local, regional, state and national levels.

Our expectations from 4-H Members:

1. The scholarship form will be completed entirely by the 4-H Member to the best of his or her ability.
2. The 4-H Member must put time and effort into the application.
3. The 4-H Member and his or her family will contribute a minimum of 25% of the registration cost, unless he or she talks to the 4-H Agent/Program Coordinator about a full scholarship.
4. Meals and snacks will not be provided.
5. Transportation will be provided to most events, however, if it is not available, the 4-H Member and family will be responsible for transportation.
6. A thank you note will be written to the Gilliam County 4-H Association for each scholarship received. If a member receives a scholarship, and does not write a thank you note, he or she may not be eligible for future scholarships.
