## 2024 DOUGLAS COUNTY FAIR WASTE MANAGEMENT JOB DESCRIPTION

## **RESPONSIBLILITIES:**

- Clean aisles at ends of barns
- Clean grooming chute area after showing finishes for the day.
- Keeping wash rack areas swept and debris-free.
- Clear public walkways of straw and manure.
- Maintain grounds in livestock areas during livestock division shows.
- Clean up each day, as needed or asked, around barns & surrounding areas.
- Water and care for 4-H outdoor display plants.
- Sign in/Check in before and after each shift with the 4-H Office
- Please note that this position is available to youth 15-19 years old. It is recommended that they not be showing animals at the County Fair.

• Must be able to use a wheelbarrow, shovel, rake, and push broom.
